Priority campaign: #KIDSOFFNAURU

- 2. Encourage your members to write letters and/or email the Prime Minister, Hon Scott Morrison, Hon David Coleman (new Minister for Immigration), Hon Peter Dutton (Minister for Home Affairs) Hon Bill Shorten, Hon Tanya Plibersek, and Hon Shayne Neumann (Shadow Minister for Immigration)
- 3. Organise actions in public places or at your MP's office and invite members of the public to sign postcards. Postcards ready to print: Prime Minister Morrison, Peter Dutton, David Coleman, Bill Shorten, Tanya Plibersek, and Shayne Neumann

4. Plan in advance to do an action on or around International Children's Day on Weds 24 October. ARAN is calling for a Day of National Action and will provide suggestions for actions in the next Update.

New Report on Nauru released 3 September by RCOA and ASRC: You can read the full report here. Coverage by ABC radio here: - 'Australia's Man Made Crisis on Nauru Six Years On', calls for 109 children and their families to be brought to Australia without delay. "We have never seen a policy so cruel, so damaging and so absolutely unnecessary. Offshore detention will be remembered in Australia's history as a moment of utter darkness" (Dr Joyce Chia, Director of Policy, RCOA). Keep up the pressure on Parliament to evacuate all children and the families off Nauru to Australia for urgent care and medical treatment, share the report on Facebook and Tweet using both hashtags: #KidsOffNauru #EvacuateNow.

'Resignation syndrome' plagues refugee kids (from The Saturday Paper 14 August 2018)

Refugee and asylum seeker children held in immigration detention are increasingly suffering from a rare syndrome associated with lengthy confinement. Speaking to BuzzFeed Australia, an unnamed health professional recently on Nauru said children with the condition "take to their beds and they stop eating, stop drinking, stop toileting themselves, stop talking ... it's like when you visit a hospice and you watch people who are dying in a hospice". Child psychologist Louise Newman said resignation syndrome – a condition diagnosed in hundreds of refugee children slated for deportation in Sweden in 2017 – was "a form of escape or dissociation; they go into a state where they look semiconscious". At least nine legal challenges brought against the federal government by human rights groups this year have resulted in judges ordering immigration authorities to fly seriously ill detention centre detainees to Australia for treatment.

- * Plan actions at MP's offices. Key messages: STOP the cruelty Restore SRSS Fair Go for Refugees – Restore SRSS Dignity not Destitution– Restore SRSS

duty of care towards people held in detention – reply by 20 September

All ARAN member groups are invited to ENDORSE the resolution that was passed at the closing session of the ARAN conference. The Resolution was put by Max Costello, Paddy McClosky (Doctors for Refugees) and Margaret Sinclair, calls on the federal government to comply with the Work Health and Safety Act 2011 which requires it to ensure the health and safety of everyone in a workplace (including detention centres). Clearly the Australian Government is in breach of this responsibility in relation to people held in detention onshore and offshore.
