# Lobby Labor MPs and Senators to withdraw the Migration Amendment Bill

Labor may seek to pass the legislation during the June Parliamentary sitting (24-27 June).

A Senate Inquiry has recommended that this atrocious Bill be passed, in spite of strong opposition from human rights organisations, legal and community advocates, and refugee and migrant communities.

The Greens and Senator David Pocock recommended the Bill be rejected. Anticipating that the Senate may seek to pass the Bill, Senator Pocock also recommended amendments. The Coalition submitted a dissenting report, recommending 17 amendments – see a brief overview of these amendments here: Amendments to the Deportation Bill suggested in the Dissenting Reports

However, Labor does not appear to be listening.

#### **Contact Labor MPs and Senators Now - phone, email, write letters:**

- 1. Urge Labor MPs and Senators to withdraw and abandon the Bill.
- 2. Highlight that refugees owed protection by Australia could be at risk of being deported to danger because:

3. Demand that people denied protection under the Fast Track assessment be given a fair process and pathways to permanency.

## 10,000 people still in visas limbo - after 10 years on 'Fast Track'

Despite the stunning efforts of those refugee women who walked from Melbourne to Canberra, and from Sydney to Canberra last year, the Labor Government has not made any significant moves to provide a fair process and permanency. Please sign the WAVE petition Calling for Permanent Visas. Discussions are underway regarding the presentation of the petition in coming months, together with the report on The Big Walk for Refugees - A Big thanks to all who got involved: Together over six weeks, 700 participants walked (and ran, swam, cycled and danced) their way through an incredible 74,000 kilometres to show support for 10,000 refugees who have been living in our communities without certainty for more than a decade. That was a total of 108 million steps, 4.4 laps of Australia, and nearly 17000 laps of Parliament.

The situation continues to be very serious for over 50 men (many now with families) still stuck in Port Moresby, as services are being withdrawn, and living allowances are not being paid. A Campaign Group convened by Kevin Sweeney is working on lobbying strategies. At this stage there is very little indication that the Australian Government is motivated to intervene. # Federal Budget - overview of provision for refugees and people seeking asylum

While there is some welcome news in the budget for refugee resettlement, there are savage cuts to the SRSS/Income Support cut for people seeking asylum. We know that people on Bridging Visas(and those with no visas) are not eligible for any Centrelink payments. The SRSS payment (now known as payments for Asylum Seeker Support) is vital for many individuals and families who cannot work. The Federal Government has cut the budget for this support by 50% in the recent budget. Spending on this vital program has been cut by 95% since 2015-16, from \$300 million to just \$16 million. In summary other budget announcements include:

- No increase to the humanitarian intake
- No increased provision of work rights, study rights and access to mainstream social support for people seeking asylum
- No support for refugees abandoned in PNG without food and financial aid
- Spending \$604 million, in the next year, keeping people in brutal offshore processing centres on Nauru
