December 2024 ARAN UPDATE



In this ARAN Update we have suggested actions to take to help support those who seek asylum in our country, but have so often faced enormous, and unnecessary obstacles - we need to keep doing all we can to bring about a fairer and more compassionate system based on human rights.

What a year it has been. All who have protested and advocated for the fair and compassionate treatment of refugees and people seeking asylum are shocked by the recent legislation of three Bills, to enable deportations with additional powers to remove people to places of potential danger, to rescind refugee status, and to deny people in immigration access to mobile phones. It's particularly disappointing that a new Deportation Bill was put forward, bundled into a 'Cruelty package' (with the previously put aside Deportation Bill from mid-2024, and 'phones' Bill that was hotly debated in

again, Labor political strategists have sacrificed the rights of refugees and people seeking asylum. We need to send Labor a clear message - refugee rights are human rights, and must not be compromised in this way.

There is ongoing concern for those 40 or so men still stranded in Port Moresby, more than 11 years after being sent to detention in PNG. At last the Australian Government has recognized the need to reinstate a living allowance, but it looks like it will be inadequate for most of the men, and those who have families. Advocates are actively engaged in discussions - we need to keep pushing on this. A big call out to Sr Jane Keogh and all those who contributed towards the huge fundraising effort - raising over \$150,000 to provide for those in PNG. This effort will need to continue but at a reduced scale.

On a brighter note, we are feeling more hopeful for those unfairly denied refugee protection under the flawed Fast Track process. Hundreds of people still waiting for permanency after 12 long years held 24/7 protests in 5 cities - the 24/7 protest continues at the Minister's office in Sydney, and in other states protests are continuing on a more occasional basis. While there are indications that the Minister may be listening, we need to keep advocating for permanent visas.

Another year has passed, and around 14,000 refugees and people seeking asylum are still trapped in Indonesia, a situation largely created as a result of Australia's ban on resettling refugees who arrived in Indonesia after 30 June 2014, including as part of Australia's annual humanitarian intake. This ban remains in place and also prevents Australian citizens from privately sponsoring refugees trapped in Indonesia. A working group has been established to build a campaign on behalf of these people who still hope for a safe and secure future.
